June 28, 2017 (Wednesday)

July 20, 2017 (Thursday)

The Legal Aid Clinic of UILS became operative today, on 20th July, 2017. Two of the Legal Aid Volunteers Jayanti Singla (5th Semester) and Adarsh Maurya (3rd Semester) to assist the State Legal Services Authority Lawyer, Advocate Gautam Bhardwaj. On the initial day, we had a case from a student who was facing problem in getting admission to a Panjab University affiliated college due to the problem regarding Gap Year. He was given proper guidance by Adv. Gautam Bhardwaj and was suggested to obtain the reason for not giving admission in writing from the concerned authorities to serve as an evidence in the Court and was suggested to file a Writ Petition in Punjab and Haryana High Court thereafter.



July 21, 2017 (Friday)

Legal Aid Clinic UILS on July 21, 2017 organised an awareness lecture on the topics viz. POCSO Act and Womens' Rights at Government Girls Model Senior Secondary School, Sector 20B Chandigarh. Five Volunteers from the clinic, Adarsh Maurya, Dilpreet Kharbanda, Kiran Kumar, Kajal Arora and KomalArora, delivered the interactive lecture and tried to make the lecture as pragmatic as possible for students. Students also participated enthusiastically and raised questions of relevance. Session ended successfully with vehement response from the students and teachers and with the beautiful quote

July 26, 2017 (Wednesday)

Children are studying religiously near the sacred places of worship whose garb is taken and misused by the people who acknowledge themselves as the stronger sex, to question the upliftment, but less do they know, Education is her Dharma, Books are her Mazhab.

September 14, 2017(Thursday)

A group of Legal Aid Volunteers visited the Institute for the Blind in sector 26 Chandigarh in a mobile van of the State Legal Services Authority, Chandigarh. The visit commenced at 11 am with a short introductory note by the Secretary of the institution Mr. B.D. Sharma who disclosed the fact that the institute runs solely on donations, without any governmental aid. The volunteers were given a tour of the institute wherein they interacted with the students, teachers and also visited the girls' hostel. The students were left in awe when they saw how those blind children had made their lives beautiful and were enjoying it to the fullest.

The volunteers engaged the students in various activities in different classes and also created awareness among them about Child Abuse by delivering short lectures.



September 24, 2017(Sunday)

Punjab Half Marathon 2017

As many as 2,000 people from different walks of life took part in the 2nd edition of 'Punjab half Marathon-2017' for a cause 'Say No to Drugs' on Sunday morning. This mega event was hosted by the State Legal Services Authority, U.T. Chandigarh, Narcotics Control Bureau along with national level trust Thrill Zone. The marathon was flagged off by Sh. Balbir Singh, District and Sessions Judge, Chandigarh. HonbleMr Justice Surya Kant inspired the participants by giving away prizes to the winners and stressed on the need for Drug Free Society.

The marathon had three categories covering the distance of 21 km 10 km and 5 km. The marathon commenced from Chandigarh club at 5.30 am which crossed Rock Garden, Sukhna Lake, Kishangarh, and IT Park and ended at the point from where it had started. Asian Marathon Champion (1992), Dr Sunita Godara was the Marathon Ambassador for the event.

30 volunteers from Legal Aid Clinic, UILS, Panjab University participated in the marathon. The volunteers were also part of organizing team. Yashika, Shivam, Rahul and helped in organizing the event and reached there at 3:30 A.M. while rest of the volunteers participated in the run. The volunteers ran 5 km marathon. The participants were deeply motivated by the run and recalled this experience as joyful. The participants resolved to say no to drugs. All the participants were given certificates and medals. Balbir Singh, the chief guest on the occasion gave away the prizes to the winners. The winners were given trophies, shoes, T-shirts and certificates.





September 25, 2017(Monday)



"अन्तHEARD" - a story telling session was organized by Legal Aid Clinic, University Institute of Legal Studies, Panjab University at the student center in the varsity on 25th September 2017. Participants were given a chance to bring out various social and legal issues in the society in the form of stories. Abstracts were invited from student fraternity as a whole. Students from University Institute of Legal Studies, University Business School, Department of Physics, Department Of English, Department of Computer Science and Applications and Department of Laws, Panjab University enthusiastically participated in the event. The outreach of the event extended to Delhi University and Priya Sharma from the Department of Sociology, Delhi University shared her views on the upbringing of a female not just by the family but by the society as a whole.

The event "IFHEARD" threw light on topics like women empowerment, mob lynching, religious and caste divide, terrorism, prostitution and constructive role of media in developing a rationale democracy. The most elusive attribute of this event was that the youth of the society put forth their views on some of the most controversial and sensitive topics and the same were graciously accepted by the

audience. The purpose of creating social and legal awareness by making the "अनHEARD" heard to the society at large was served with a great success.



September 26, 2017(Tuesday)

'Nukkadnatak-Dhuan'

A group of 31 students decided to portray that addiction of drugs which may start due to any reason but leads one to one's own dooms day. The 'nukkadnatak-Dhuan' basically generated legal awareness about the effects of drugs including its repercussions, punishments and rehabilitation for the same. The group portrayed how drugs affect a family and student's lifestyle and future.

The first scene enumerated a situation of domestic violence where husband comes home drunk and beats his wife without any reason and Laddi (their son) protects his mother. The second scene started with Laddi giving good news about his 90% score in 12th examination and his admission in Panjab University to his parents. Thereafter his father affirmed him for getting a loan of Rs3 lacs for his studies on a promise that Laddi will study hard and get his mother medically treated.

Scene three opens with Laddi dancing out of elation on entering university and eight personified drugs haunting him. Scene four opens with Laddi's friends alluring him to drink alcohol and get stoned while he was studying. Gradually he and his friends enjoy while drinking alcohol and weed altogether. Scene five portrayed Laddi's fainting because of high dose of drugs and his parents visiting him after one of his friends called them. While his parents were trying to revive him, he wakes up and starts beating his parents while demanding money for drugs. Scene six portrayed a war between Laddi and all drugs and finally Laddi's win

over drugs. The conclusion comprised of monologues by some students enlightening the aspects of rehabilitation and punishments.



September 27, 2017(Wednesday)

A street play was organized by Nruture Nature Global and Legal Aid Clinic, University Institute of Legal Studies in collaboration with Rotaract Club Shivalik on September 27th in Sector-17, Chandigarh.The students who performed the play were 29 in number. The play was entitled 'Aaj Ki Durga' which highlighted the issues being faced by women even after 70 years of freedom. Through this act, they conveyed a message that girls are not helpless, they are just quiet.

Every time it is a girl who is asked to 'compromise' and expected to just take things without complaining. The play was divided into 6 different scenes and a conclusion in the end, demonstrating various problems like discrimination on the basis of sex or gender, parents permitting their sons to go for higher studies but denying daughters' their right to education and asking them to get married.



Other issues on which they focused were child marriage, female foeticide which are illegal but still being practiced in few areas. The matter of eve teasing was pointed which eventually leads to sexual harassment or rape.



How a girl's outfit is deemed as the cause of the rape, while the rapist have been accepted as a part of the society. 'Ab bhai ladkiyo ko tohsambhalke hi rehnapadtahai.'The play showed how females are always held responsible for everything even when they are the ones who are suffering from physical or mental harassment. The play was cusped with a poetry which meant that girls are not weak and can do anything.



October 2,2017(Monday)

On the birth anniversary of Mahatma Gandhi ji and third anniversary of Hon'ble Prime Minister's premier programme- the Swachh Bharat Abhiyan, the Legal Aid Clinic of University Institute of Legal Studies, Panjab University and Nurture Nature Global organized a Street Play on the Topic "**Kudrat ka Keherr**" at Sector 17 Plaza, Chandigarh.



The street play was the third play of the duos' 'Jann ki Baat' campaign which will be showcasing a number of plays on different social issues throughout October and November. The street play was performed by the Students of University Institute of Legal Studies. The street play showcased the environmental issues that are being caused by the Humans and eventually they are the sufferers of the same.

The play showcased that firstly humans waste their resources(water), and when the nature reverts back(drought), the sufferers are the humans themselves. It gave a message that it is us who cause such a problem and hence the humans are eventually the affected ones. We should use our resources well and save the environment. Mostly the people living in the urban area waste their resources but the farmers in the rural suffer due to deficiency of it.

The play also showcased that we should not litter as soil is also one of our natural resources and reminded the audience about the Swachh Bharat Abhiyan.





October 16,2017(Monday)

The 5th year students of UILS, Panjab University in collaboration with Nature Nurture Global performed a street play titled "AkhirKyun" at Sukhna Lake in the evening. The theme of their play was domestic abuse which showcased domestic abuse suffered by different members of the family; be it wife, old parents or children. A total of 30 students participated in the play.

Domestic abuse is one of the many evils from which Indian society is still suffering and the victims of domestic abuse do not come forward to protect their family name and honour. Thus the play was an attempt to make the audience aware of their rights, to motivate them to take a step forward towards their freedom.



The play started with a young couple fighting on a trivial matter where only the wife is blamed and not the husband and she is left helpless and devastated by her spouse. Then there was a call for play to gather the audience. The play was majorly divided into 3 parts with each part focusing on a different victim.

In the first part, plight of a working woman was shown, who is working the same amount of time in the office as her husband, but is still expected to manage the household job alone without any help from other members of the family. If she complains, she is advised to leave her job and focus on her house as that is her prime duty.

The second part showed how old parents are emotionally, physically and mentally tortured by their own blood in the greed of property and the third part touched upon the issue of sexual abuse of children by their own relatives. The play ended with a legal message in which various acts were brought to the knowledge of the audience under which they can seek help. In the end social message was sent to not stay quiet but to come forward and to raise their voice against domestic abuse.

The performance and efforts of the students were applauded by the audience which had gathered. Some people specially approached the students whose performance they had liked and congratulated them for the success of the play.



October 17,2017(Tuesday)

All round social and environmental degradation, pervasive corruption and selfseeking politics have become the norm. Today a school teenager is more captivated by drugs than by books, college going adults take pride in activities like stalking, gawking, eve-teasing; middle age people treat their own parents as financial burden on them. To rebuke this practice and to boldly say the truths of our deploring culture a group of 37 students decided to portray the causes of cultural degradation and consequences of it.



The 'nukkadnatak-Kalyug Ka Dhamal' which started as a compulsory academic activity, ended in each one of us giving our best to reach out to the audience of 150 people approximately. The play basically generated social awareness about the causes of cultural degradation and legal remedies which society can resort to. Through first scene we had shown that how a child is being neglected by the family which gradually ruins the character of that child. Parents greatly affect their children's behavior and parents' ignorant behavior can be detrimental to the child's development.



A scene wherein a child is neglected by his parents and then a class room scene wherein the overpowering evil elements of the society inculcated amongst children through media and various other sources drags that neglected child towards everything which is injurious to his own and society's development.

In Scene 2, the daily tolerance that the women in this society bear had been portrayed. It is the type of violence that she confronts outside the four walls of her house and which is ignored and not taken as a serious issue. In this scene there is a group of stalkers which harasses a girl passing by. She is neither able to tolerate their brash behavior nor able to speak out in her defense and so she feels herself to be trapped in a big trouble and instead of taking any affirmative action she breaks down. Hence, the same group of stalkers continues to harass the other girls.

In third scene we had shown the despicable position of aged, infirmed people in our society. In this scene there is a family setup wherein the old parents crave for their daily needs before their son and daughter-in-law but the daughter-in-law bluntly refuses them. Thereafter on the request of her husband she in pretense behaves nicely with them so that they may grab the property with fraud and flatter which is currently under the ownership of the parents.

Gradually because of the deceit of their children the parents are forced to leave their own house and a social activist comes up for their help and aware them about their legal rights.

October 24, 2017 (Tuesday) STREET PLAY "JANLEVA NETWORK"

A group of 9th semester from 5-year law programme of UILS, Panjab University performed a street play "JANKEVA NETWORK" in the parking area of the main market, Sector 22, Chandigarh on 24th September 2017. The play was based on the topic of ill effects of blind use of social apps. The aim of the play was to create legal awareness regarding such apps leading to depression, suicides, mental and other related problems even showcasing legal rights, remedies and day-to-day solutions which can be observed by youth, parents, teachers and the whole society at large.



The act included scenes of SELFIE DEATHS, BODY SHAMING, MISSUSE OF WHATSAAP-TINDER, DEPRESSION, RAPE & BLUE WHALE.

The play was a resounding success, a huge crowd gathered to witness the play and appreciated the performance of the students., and the efforts made by the students in preparation were to a good use of spreading awareness. The students via the play tried to convey the message that the atrocities common in our nation should not be accepted by the women at large and there is concrete law present to counter these wrongdoings.



The students also enjoyed performing in the aura of Sector 22 Market. The students expect that the play will inculcate a feeling amongst the people and the wrongs committed might be put to rest through the awareness they and the organizer are trying to spread across.

The 5th year students of University Institute of Legal Studies (UILS), Panjab University in collaboration with Nurture Nature Global performed a street play at Dhanas on an emerging issue – 'Organ Donation'. The Play aimed at raising awareness amongst the people on this issue and simultaneously debunks the many myths associated with it due to which people refrain from organ donation as well as blood donation. The play had 3 main scenes that portrayed the reluctance on the part of people when it comes to the selfless act of organ donation and blood donation.



During the course of the play, various concerns surrounding this sensitive topic that deter them from donating their organs like an old person's organs are of no use; financial aspect; religious beliefs; and if a person is an organ donor the doctors might not even try to save him/her, etc. were also clarified with relevant information.
